


Co-op Locations

Co-op operates in four primary areas: agriculture, food, home and building solutions, and energy. Local Co-ops may also provide other services.



We Fuel Western Canada

- Distributes **17 million** litres of fuel products, per day
- **5.6 billion** litres of fuel sold, per year
- Fleet of **250 b-train units** travelled **49 million** kilometres



Co-op Ethanol Complex (CEC)



The CEC has been producing and shipping ethanol since 2008. FCL purchased the facility in the Summer of 2019.

- Based near Belle Plaine, Sask.
- Produces up to **150 million litres**, per year
- Generates between **\$100 - \$140 million** in economic impacts every year
- **350,000 tonnes** of grain and other crops purchased annually from ~ **270+** Western Canadian producers

Problem statement

Our organization currently uses JDE for Purchase Order and Requisition approval. Approval is routed via email. Based on current functionality, user has to login to JDE to approve their POs and Reqs.

Apart from JDE approvals, users approve various other documents that includes contracts, budgets, DocuSign etc.

Challenges

Seamless Process: JDE approvals happens in JDE. With approvers in mobility creates issue with timely approvals.

Centralized View: Need a centralized view of JDE and non JDE approvals in one view. Currently users get approvals in email, JDE, other 3rd party systems

Efficiency: Different logins, connectivity requirements like OKTA, VPN etc makes approval process tedious.

Compliance and Risk: Secured process and audit trail are essentials in having valid solution.

- Enhanced Efficiency by meeting approvers where they are
- Utilizing existing eco system (Microsoft Teams with JDE Orchestration)
- Minimal time needed for user adoption
- No new skillset or tools needed



Where should the approval flow reside? Should we change approval flow to overcome JDE limitations?

- Connectivity

How should we connect Power Automate with JDE, type of license required, permissions, firewalls etc.

Fed Coop Solution

- Determination of Approval Flow → Use JDE Approval Flow
- Connectivity → JDE Orchestration, Power Platform Premium License
- Security → Use Service Account for JDE → Power Automate.
 - Use SSO for Power Automate → JDE to approve or Reject
- Scoping → Limit to existing JDE PO approval process
- Rollout Plan → Implement to IT department as Phase 1 then roll out to other departments as Phase 2

Fed Coop Next Steps

Lessons Learned

- Challenges getting Power Platform whitelisted to connect to AIS server.
- Some non prod environments are not using SSO to connect JDE for approvals. Need to factor this in design.
- Approval Delegation was not factored in POC. Will be added to phase 2 roll-out.
- Remember to disable approval workflow in JDE.
- Build in support for updates to PO during active approval.

Fed Coop Next Steps

Next Steps

- Phase 1 - Go Live is scheduled for July 1, 2025
- Phase 2 - Roll out to shortlisted departments by Aug 31, 2025
- Add non JDE approval Flows in Teams by end of the year.
